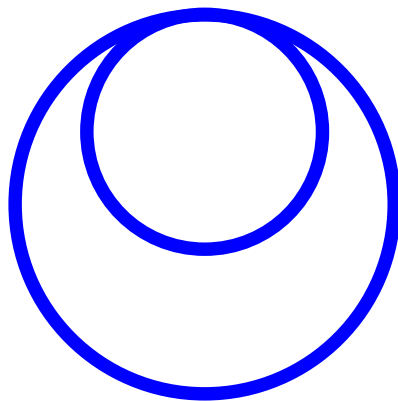

POLLUTION REMEDIATION

In a world which is constantly concerned about the effects of climate change, the reduction of the animal and vegetable biodiversity, desertification and the erosion of the agricultural soils ... in a world in which drinkable water becomes an ever more precious resource and the fertility of the Earth is jeopardised by pollution, the improvement of the Earth itself and the conscious renewal of its balance is one of the fundamental objectives for anyone who wants to establish a conscious relationship with Nature.

Aware of this, EUREKA has been working for years to establish suitable means for lasting and real solutions to the problems listed.

By researching in the field of homeopathy, today we can address the pollution, and the general crises, through the employment of rapidly effective isotherapeutic products lacking any type of harmful residue and at extremely low cost.

REMOVING POLLUTION: LEAD

Experimentations and results

EUREKA has many experiences in the field of the lead remediation. The experimentation that we introduce now took place in 1996 in collaboration with the University of Parma (Italy).

The test was conducted for a graduation thesis on the subject of remediating plants and soils with the homeopathic isotherapeutic methods of EUREKA.

WHAT IS AN "ISOTHERAPEUTIC" PRODUCT?

An isotherapeutic product (from the Greek "hiso" = the same, and "terapia" = cure), is a product which cures a pathological process using the same substance which caused the illness (in our case the polluting substance) or another substance directly linked to it (e. g. the purifying exudates in inflammation).

TEST: purification from lead residues of soil and plants adjacent to the government road S.S. 13 "Pontebbana", Codroipo (UD)

METHOD: the land was divided into 12 sections, some of which were given repeated sprays with homeopathic isotherapeutic products over three weeks. Plant samples were taken over that period, along with surface and subsoil soil samples which were all measured for the presence of lead.

RESULTS:

- Max decay of Pb values in plants: - 51,11%
- Max decay of Pb values in top-soil: -13,04%
- Max decay of Pb values in sub-soil: -13,16%

REMOVING POLLUTION:

HEAVY METALS

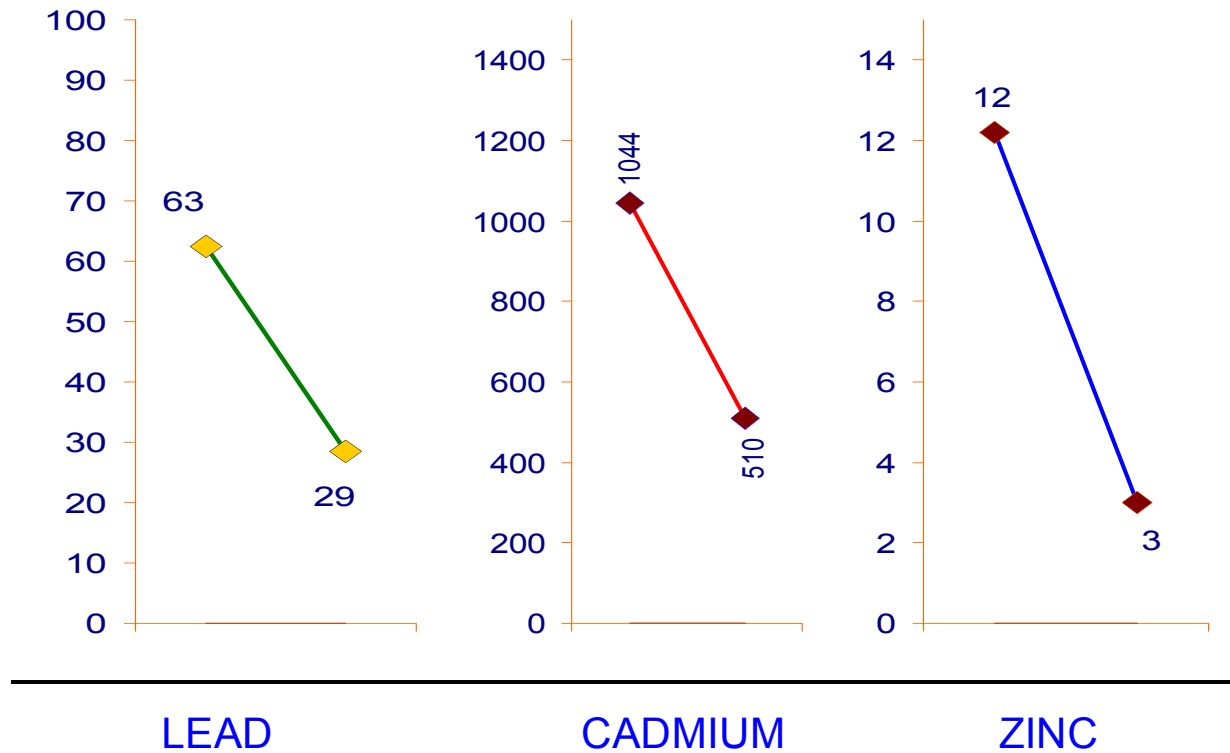
1996 experiment in collaboration with the Podologic Center for the guardianship of the environment of the University of Lubiana (Slovenia).

METHOD

The soil and the plants polluted by Lead, Cadmium and Zinc were sprayed with the homeopathic isotherapeutic products of EUREKA. The isotherapeutic product "Anti-Lead" was sprayed twice with 9 day intervals at 10 mls diluted in 40 litres of water per hectare.

The preparation "Anti-Lead" has also proved to be very effective against Cadmium and Zinc.

- **Max decay of Pb values on soil: - 60 %**
- **Max decay of Pb values on leaves: - 55 %**
- **Max decay of Cd values on soil: - 75 %**
- **Max decay of Zn values on soil: - 50 %**

POLLUTION REMEDIATION:

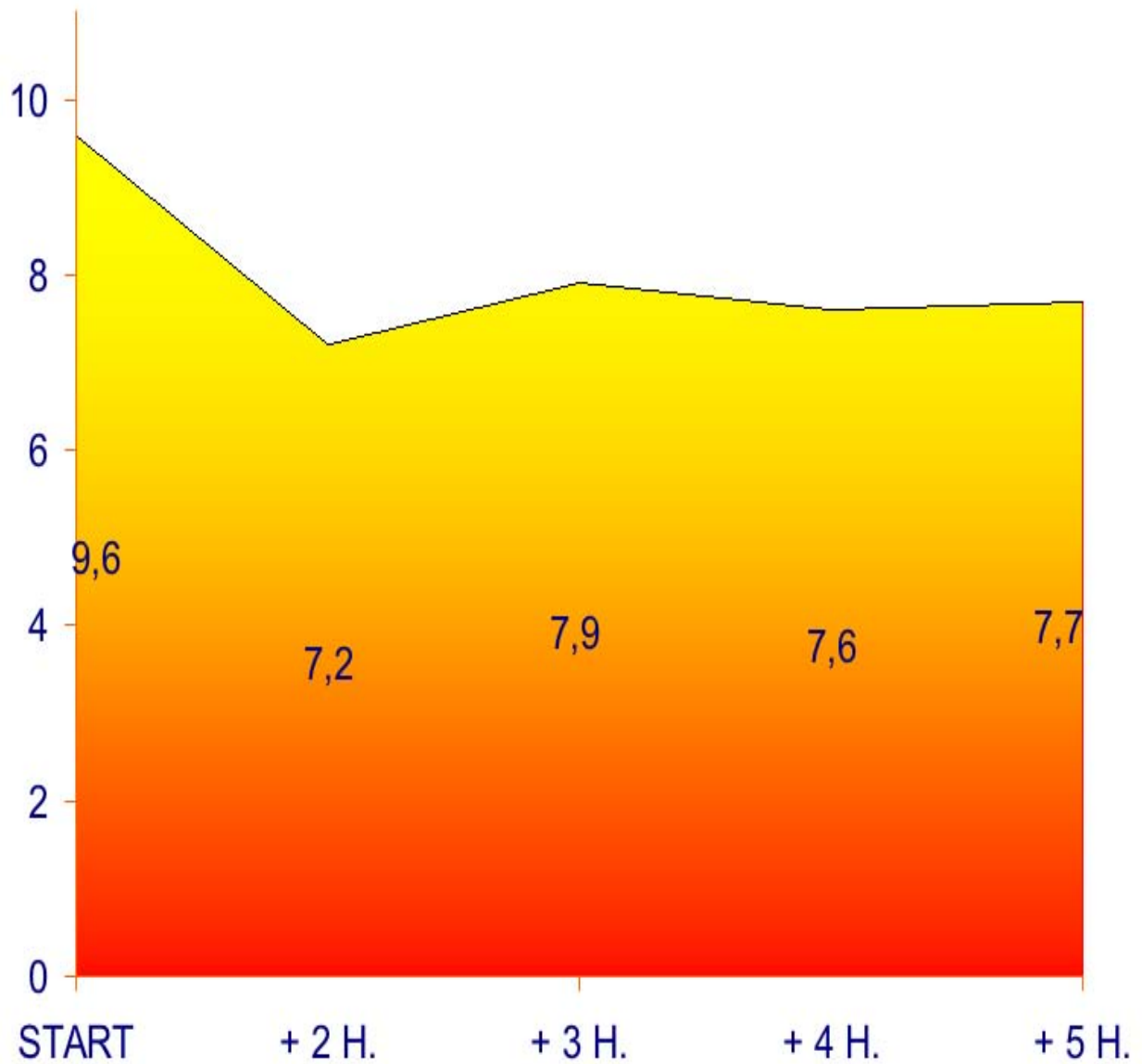
ATRAZINE

EUREKA addressed the problem of atrazine in collaboration with the Department of Environmental Guardianship of the University of Lubiana, Slovenia.

The tests were undertaken according to the norms DIN 8407/F12. '97.

METHOD: the test was performed with 40ml of homeopathic hisoterapic product "Anti-Atrazine" per 2 litres of water containing 0.0096 mgs / l of atrazine.

RESULT:

After two hours the measured reduction was 25 %.
